#### **LOT OWNERS NEWS**

At the last Social Club meeting on Thursday, Dec. 13, the members present voted 49-5 (with 2 abstaining) to join with the Laurel Estates Lot Owners Assoc. Inc. on a trial basis for the year 2013. This action was necessary because our social club is no longer recognized as a corporation by the State of Florida. All social activities for Laurel Estates will be under a "social committee" with a chair person to be named by the president of the lot owners assoc. All events currently on the calendar through April will be held as scheduled. Monies now in the social club bank account will be transferred to the lot owners bank account. Accounting by the treasurer will show two separate funds and will be reported as such. Dues for this coming year have not been determined as of yet. The lot owners board will make a recommendation re: dues at their January meeting with approval to be voted on at the annual meeting Jan. 18, 2013. Any changes to the lot owners by-laws will not be made until the annual meeting in 2014.

At their December meeting, the lot owners board of directors approved a change to the monthly meeting agenda by voting to allow residents to address the board during a time of "public comments". This change will begin with the Jan. 3<sup>rd</sup> meeting. Residents may address the board (with a 3 minute time limit) on any subject. The monthly meetings will be held in the large social room.
